Stevens pulled out a black square looking handgun (possibly a Glock) and waived it at everyone and then Sauve and Stevens started wrestling for the gun. At one point Stevens put the barrel of the gun to Sauve's head and throat.

After the incident Stevens called their mother Janice Rundles.

Jasiek said that she is not sure if Stevens has a concealed weapons permit and said Chief Murch was looking in to it. She also said that *she is not looking for criminal charges she is just concerned that Stevens is too unstable to own a firearm.* (CCAO 000014)

Clark Stevens (28) arrived at the house. He asked me why we were there and then started to yell at me; asked me to talk to him in private; I declined and he grabbed my neck to try to force me out the door and when he had grabbed me, Michael yelled at him and slowly approached us both, when Clark pulled out his concealed handgun. (CCAO 000004)

The gun was intermittently held to Michael's head and throat. After this altercation, Clark called my mother on his cell phone Sister's Statement:

I'm concerned for my brother's <u>safety and mental well-being and I believe he should</u> <u>not be allowed to own a deadly weapon</u>. His reaction was extremely concerning to me and my friends. (CCAO 000005) (Click Here)

Clark grabs me by the neck in an effort to throw me out of the barn. Then *Clark pulls handgun from behind his waist, puts barrel to head of Michael.* A Struggle ensues over the gun. Clark prevails and demands both Michael & I leave.

Clark & Janice discuss the situation via phone as we are leaving. It is now 11:15pm. I reported this incident to Chet Murch of the Lee Police December 9, 2013. (CCAO 000006)

driveway and saw lights on in the barn and *he said he had his handgun with him* but it was <u>unloaded</u> and he said that when he saw that Michael was there, <u>he had</u> <u>loaded the gun</u> and put it um somewhere, not carrying it out, you know in his hand but put it somewhere and um went in CCAO 45

- Q. Ok um you said that he had told you that he told them to leave, did he tell you what words he used or anything like that or just that he said he told them to leave?
- A. No, at that point, he just said that he had told them to leave and *there was some confusion in my mind* as to whether they were agreeing to leave or not and he said that he thought they were gathering their things and getting ready to leave. CCAO 49
