CHRONOLOGY OF JESSE BROOKS' ABUSE AS RETALIATION FOR RECORDS REQUESTS

BOGUS URINALYSIS VIOLATIONS

Corrections officers changed testing criteria to the lowest concentration which only proves someone has used drugs. The prison doctor prescribed Jesse drugs for his severe chronic back pain but officers refused to take that into consideration. Deputy Warden Solis informed Jesse that he would have to test negative despite Jesse's medication schedule. DW Solis also refused Jesse's request to be put in isolation and tested every 48 hours at his expense to establish a baseline drug level to prove he was only taking what was administered directly to him. When Jesse appealed his tickets, officers refused to look at documentary evidence from two of the largest drug laboratories Millennium v. Ameritox proving that urinalysis cannot determine patient compliance levels. DOC's own drug lab TASC also verified that only a blood test could confirm levels but his appeals were denied. Instead he was found guilty based on the assumption "it was more probable than not."

RETALIATION FOR CHALLENGING URINALYSIS TICKETS -ISSUED REFUSAL TO WORK/DISORDERLY CONDUCT VIOLATION

Despite Jesse's chronic spinal condition he was give "extra duty" work bending and lifting in the blazing Arizona sun. Jesse was charged with disorderly conduct when he tried to present his medical waiver for light duty and no sun because of his fair complexion. In Jesse's years of incarceration no one has ever claimed he was disrespectful and in fact, he has been commended for being well mannered.

SOLITARY CONFINEMENT – PUNISHMENT FOR CONTRIVED VIOLATIONS

As a consequence of the erroneous tickets Jesse was placed in "the hole" 5/22/15 for 60 days and confined to a 10 x 8 area, which restricted his physical movement. He was allowed out at 5:30 am for his rec time but that only consists of a 20 x 20 room. Jesse needs to walk regularly for his well-documented chronic back pain, which he was being treated for long

before his incarceration. They placed him on the sunny side of the building, no AC, 117 degree temperatures. On 6/12/15 they abruptly discontinued his pain medication. He suffered with severe pain, medication withdrawal, and tortuous heat.

NO URINALYSIS TESTS AFTER JESSE IS PLACED IN SOLITARY CONFINEMENT

After Jesse was moved to "the hole" 5/22/15 - they never administered a single urinalysis test because it would have proved that he was never taking anything but what was prescribed directly to him.

PAIN MEDICATION ABRUPTLY DISCONTINUED

Jesse's pain medication was abruptly stopped while in solitary confinement without a medical evaluation or doctor's order. Jesse's medical history is well-documented: enchondroma, (failed back) artificial spinal implant at L5-S1 compression fracture, spinal fracture at T12, shoulder injuries, elbow injuries and repeated hernia surgeries.

REVOKED VISITATION INDEFINITELY

Based on the bogus disciplinary tickets Jesse's visitation was revoked INDEFINITELY in July 2014. Jesse's family requested a non-contact bereavement visit in December 2014 after his grandmother and cousin Jason, who was like a brother to Jesse, died within a 7- day period. Deputy Warden Solis DENIED the request.

REVOKED PHONE PRIVILEGES

Based on the bogus disciplinary tickets they revoked his phone privilege for one year.

UPDATE: ARIZONA SUPERIOR COURT REVERSED THE UNWARRANTED TICKETS

11/28/16 the Arizona Superior Court reversed the disciplinary tickets citing error but Jesse was severely punished for years, deprived of effective pain medication, deprived of family visits for 2-1/2 years,

deprived of phone contact, and continues to be locked-down 22 hours per claim they were only taking orders.
