- Q. You were trying to tell those men-and, in fact, you said just a minute ago, what? You said that you were talking to Knight specifically with Vrooman and Jay Brooks there, and you said, I'm coming for you, right?
- A. Well, I didn't just say that a minute ago, but-

- Q. And you told us you're what, 6'4", sir?
- A. Correct.
- Q. And you're sitting here now about 240 pounds. Is that right?
- A. The last time I weighed myself, which was last Thursday, I weighed 232 pounds.
